All Voter Members,

ELECTION PROGRAMME 2026-28

This is to notify to all the members that General Elections of the Executive Committee and Office Bearers of Pakistan Textile Exporters Association will be held under The Trade Organizations Act, 2013, The Trade Organizations Rules, 2013 and Memorandum & Articles of Association.

1. Elections would be held for the vacant seats of 24 members of Executive Committee retiring on 30.09.2026 after completing their 2 years' tenure.
2. As per Trade Organizations Act No. II, of 2013, clause 2(k), elections would be held for office of Chairman, Senior Vice Chairman and Vice Chairman amongst the Executive Committee Members.
3. Election Schedule for elections of Executive Committee Members and Office Bearers is attached.
4. As per Trade Organizations Act clause 11 & 11(b), tenure of Office Bearers for 2026-28 will be two (2) years starting from 1st October, 2026 to 30th September, 2028 and tenure of members of Executive Committee elected in biennial elections 2026-28 will be two (2) years starting from 1st October, 2026 (T.O. Rule 21(13)).
5. As per Trade Organizations Rules, 2013 clause 15, only such Companies/Firms/Proprietor concerns will be eligible to vote for the elections: -
 - a. who have been enrolled as Members of Association and have completed 2 years of valid membership of Association as on or before 15.07.2026.
 - b. and have paid their current subscriptions/renewal fee, other dues and have furnished proof of filing of annual return of Income Tax under Income Tax Ordinance 2001 or Assessment Order for preceding assessment year in the name of firm/proprietary concern/company.
 - c. and have deposited their Identity Cards or have notified any change of representative by 18.07.2026, shall be entitled to cast vote or stand for elections or nominate a candidate for elections.
 - d. Only one person who is Director/Partner or Proprietor of a Firm/Company which is valid member of the Association shall be eligible to contest from his Firm.
6. ONLY Proprietor, Partner of a Firm or Director of the Company concerned or G.M (in case of multi-national Company) shall be entitled to cast his vote at the time of Biennial Elections if he has already been nominated for voting and registered as such with the Secretary General and his name appears on the final list of voters. In case any person is Director or Proprietor/Partner of more than one Firms/Companies, he shall be entitled to cast only ONE vote and not of other sister concerns.
7. All members should ensure that their Identity Cards complete in all respects are available in the office of the Association. Those members who have not yet

submitted Identity Cards may do so by **18.07.2026**. Identity Card Forms can be obtained from the PTEA's Office on any working day. Identity Card Form is also enclosed with Election Programme.

8. No Vote by proxy will be cast during the Elections 2026-28.
9. Polling will be held in the office of the Association located at 30/7 Civil Lines behind State Bank, Faisalabad from 9 A.M. to 5 P.M. as under: -
 - i. For Executive Committee on **08.09.2026**.
 - ii. For Office Bearers on **12.09.2026**. (Chairman, Senior Vice Chairman & Vice Chairman)
10. Any candidate or his agent wishing to be present at the time of scrutiny of nomination papers will be free to do so after prior notice in writing to the Secretary General a day before.
11. The Candidates can appoint one Polling Agent each and will inform the Election Commission in writing on their letter head accordingly.
12. Each candidate will provide one copy of his National Identity Card and 5xpassport size photographs at the time of filing of nomination papers in PTEA Office on **20.08.2026** which is the last date for filing of nomination papers.
13. For all election purposes Office Hours will be from 9 A.M. to 5 P.M.

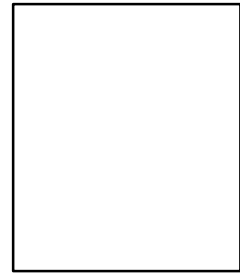
